Flood Resilience Community Engagement Officers- J Grant & D Harsley

Cllr Miss Carrick welcomed the officers to the meeting. They help the community put flood plans in place and a flood warden receives a text when the river reaches a certain height, an alert via telephone/email when the water floods the footpaths and a severe warning is issued in extreme circumstances. The flood warden has contact with the incident room team. There is no risk involved and is mainly a link to the community. A meeting will be arranged with the Community Resilience Group who already have an Emergency Plan in place. DCC provide sandbags that are already being stored at the Wolsingham Depot.

Matters Arising

- 1. JOINING MEETINGS BY ZOOM Cllrs cannot join Parish Council meetings by ZOOM which was checked with CDALC. Following the Rt Hon Angela Rayners speech there is a consultation which ends on 19th December. The consultation regards Enabling Remote Attendance and Proxy Voting at local authority meetings. The councillors feel that they prefer in person meetings. You need to be able to get the feel of the meeting which you only get by face-to-face meetings. For confidential discussions you need to know who is actually in the room. Then there is the problem with internet connections. Resolved: Clerk to write
- **2. BONDISLE ALLOTMENTS** Complete Weed Control visited the allotment site on 10th October and everything is looking good with no visible JKW. The site was treated to keep a sterile site ready for next year.
- **3.** PLANNING ENFORCEMENT RIVERSIDE CARAVAN PARK, BRIDGE END, FROSTERLEY The site was visited and there are some works going on that are in breach of planning control. The Planning department will work with the developer to get an application submitted for the scheme.

The land concerned provides vehicle access to the allotments at Willard Grove. The deeds for the allotments are held with Hodgson & Angus. Resolved: The councillors will not sell any part of that land. Clerk to write to the resident.
- 2. Cllr Mrs Smart brought it to the clerks' attention that a tree had fallen down on the sewage pipe over the Rookhope Burn. This was reported to Northumbrian Water. The tree has been removed which was a large sycamore tree.
- 3. Cllr Mrs Thompson asked the clerk to report a blocked drain just before the Ambulance Station at St Johns Chapel. This was reported to DCC who have referred it to the gully maintenance team. Also the layby opposite the turn in to Rose Hill farm the potholes are massive so Cllr Mrs Thompson asked the clerk to report them to DCC. The potholes have been added onto the works programme. All the drains are now sorted.
- 4. The neighbourhood Warden had received a report of some fly tipping between Willard Grove and Coronation Avenue. D Hunt removed the pushchair for us within hours of the report.
